Subject : Amendment in Rule 75 and 76 of Rajasthan Civil Services (Pension) Rules, 1996.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely :-

1. These rules may be called the Rajasthan Civil Services (Pension) (Amendment) Rules, 2009.
2. These rules shall come into force with immediate effect.
3. In the aforesaid rules - the existing sub-rule (2) of Rule 75 and sub-rule (1) of Rule 76 shall be substituted by the following, namely: -
"75(2) (a) The amount of ex-gratia grant, when the Government servant dies under the circumstance mentioned in clause (a) of sub rule (1) shall be as follows: -

	Sum of Running Pay Band plus Grade Pay	Amount of ex-gratia grant
(i)	Upto Rs.10000/-	Rs.50,000/-
(ii)	Above Rs.10000/- but below Rs.20000/-	Rs.80,000/-
(iii)	Rs. 20000/- and above	Rs.1,00,000/-

- (b) The amount of ex-gratia grant, when the Government servant dies under any of the circumstances mentioned in clause (b) to (f) of sub rule (1) shall be Rs.10 Lakhs.

Provided that families of deceased Government servants, who are also granted relief from sundry Government sources, such as, the Prime Minister's Relief Fund, Chief Minister's Relief Fund, etc. In such cases, it should be ensured that the aggregate of the relief / ex-gratia grant paid from different sources does not exceed Rs.10 Lakhs in each individual case."

"76. Ex-gratia grant to the family of a Police/Civil Defence & Home Guard personnel who die due to injury intentionally inflicted while on duty by a terrorist/ Militant / Extremist.

- (1) Subject to the provisions of this Chapter, except as otherwise provided, an 'ex-gratia grant' of Rs.10 Lakhs shall be admissible to the family of Police/Civil Defence & Home Guard personnel of any rank who dies due to injury intentionally inflicted while on duty by a 'terrorist'. The expression 'Terrorist / Militant/ Extremist' shall have

meaning as defined in Section 2(1)(h) of the Terrorist and Disruptive Activities (Prevention) Act, 1987. The ex-gratia grant shall be admissible in addition to other death-cum-retirement benefits available under these rules. However, in a case where ex-gratia is granted under this rule, no ex-gratia shall be admissible under Rule 75.

Provided that families of deceased Government servants, who are also granted relief from sundry Government sources, such as, the Prime Minister's Relief Fund, Chief Minister's Relief Fund, etc. In such cases, it should be ensured that the aggregate of the relief / ex-gratia grant paid from different sources does not exceed Rs.10 Lakhs in each individual case."

4. In Government of Rajasthan's Decision No. 1 to 3, the existing words and figures "Rs.1,25,000" and "Rs.60,000", wherever appearing, shall be substituted by the words and figures "Rs.10 Lakh" and "Rs.5 Lakh" respectively.
